



OLD IVANHOE SOCCER CLUB - PLAYFOOTBALL TERMS AND CONDITIONS

These Terms and Conditions apply to all players and non-players (volunteers, coaches, team managers) and their parents/guardians if the registered participant is under 18 years of age.

By registering with Football Australia using the Football Australia Registration System (**PlayFootball**) you (the Member) (and, if the Member is under 18 years of age, the Member's parent or legal guardian) agree to abide by the **Football Australia PlayFootball Registration Terms and Conditions** and the Football Victoria **PlayFootball Registration Terms and Conditions** as well as the following terms and conditions (Terms) in relation to your participation in football at Old Ivanhoe Soccer Club (the Club):

Rules and Regulations

You agree to comply with all Football Australia and Football Victoria Rules, Regulations and Policies including but not limited to the *Working with Children Check Policy, Grievance, Disciplinary & Tribunal By-Law (GDT); Codes of Conduct and Ethics; Registration Regulations;* and the *Rules of Competitions* relevant to the football competitions the Club participates in.

You agree to comply with all the Constitution, By-Laws, Policies and Rules of the Club and directives from the Club published through its normal communication channels.

Registration and Membership

You warrant that the information provided is current and correct.

Only applications submitted with the appropriate fee will be accepted by the Club. The membership fee will be refunded if the Club is unable to accept the application less any bank charges incurred.

Membership Cancellation: Please contact the club if you need to cancel your membership. Refunds will remain at the discretion of the Club (who will consider timing of requests, costs incurred and FA/FV fees and specific circumstances).



Injury and Insurance

Players and non-playing role participants acknowledge that football is a contact sport and accordingly players/parents and children release and indemnify the Club in respect of any claim whatsoever arising out of any injury, loss or damage suffered as a result of any player participating in any authorised or unauthorised Club football training or game.

Although players are covered by *Football Victoria Personal Accident Insurance Cover* (Cover) whilst playing or training, Players/parents acknowledge that the Club will not be liable for any cost not covered by the Cover.

The Club strongly recommends that you/your children be covered by your own private health insurance.

Team Allocations

Allocation of players to teams will be at the discretion of the Club.

Volunteering and Support

We are a community-based club with a heavy reliance on parent-support. Over the course of the season, we will make reasonable requests to all player-parents to give time freely with activities such as the set-up of grounds, 'running the line', team-management and assisting with the club fundraisers.

Discipline and Behaviour

The Club reserves the right to suspend or expel any player, coach or volunteer for failing to abide by the Club's Constitution, rules, regulations, policies and Codes of Conduct/Behaviour.

Privacy

Further to the Privacy Statements in both the *Football Australia and Football Victoria PlayFootball Terms and Conditions* documents, by registering you accept that your contact details may be released to the Coach, Program Manager, Team Manager and any other necessary party internal to the Club for the purposes of communication and the administration of football.

Working with Children

It is a legal requirement for the Club to obtain the details of any individual over the age of 18 that is supporting the Club in a non-playing capacity (e.g. Coach, Team Manager, Administrator). Please see the *FV Working with Children Check Policy* for further details.



Use of your Image

Further to the *Football Australia PlayFootball Terms and Conditions*, registration implies that you consent for your or your child's photo to be used for the promotion of the Club and Football across the Clubs website and social media channels.

DISCLAIMER & WAIVER

Each player or parent/guardian of player agrees that the activity organised or conducted by Old Ivanhoe SC is in the nature of sport and as such has some dangers and risks, which may include the risk of injury to the participant. The parent(s)/guardian also agrees that due to the nature of the activity, it would be unreasonable for Old Ivanhoe SC to be in any way responsible for any injury to the participant and the parent/guardian, to the full extent permitted by law, waives all of his or her and the participants legal rights of action against and fully releases Old Ivanhoe SC for loss, damages, injury or death howsoever arising out of or in relation to the participation by the participant in the activities conducted or organized by Old Ivanhoe SC including without limitation for any neglect or tortuous act of omission, breach of duty, breach of contract or breach of statutory duty on the part of Old Ivanhoe SC, its office bearers, directors, employees, agents or sponsors. The parent/guardian agrees that he or she has enrolled the participant freely, voluntarily and absolutely at his or her own discretion and risk and with full appreciation of the nature and extent of all risks involved in the activity. This waiver binds the participant and his or her parents/guardians.

In the event of a medical emergency where the parent / guardian cannot be contacted, you consent and authorise the officials of the Old Ivanhoe SC seeking or where appropriate administering such emergency medical treatment as deemed necessary by a legally qualified medical practitioner and agree to meet the costs of any treatment or procedures incurred by the Old Ivanhoe SC. Each player or parent / guardian acknowledges they have read and understand this waiver of my legal rights and that of the participant. The Parent/Guardian & player acknowledge that this is an application for registration only. Submission of an application for registration does not guarantee a placement in a squad. The Parent/Guardian & player acknowledge that the total fee will ONLY be refunded if the application is not accepted. Refunds are subject to approval and an administration fee applies.
